- If payment in full is not received within 30 days of the billing date, a delinquent chapter will receive a warning letter (30 Day Notice). - File IRS Form 990 by the 15th day of the fifth month following your chapter's fiscal year end. Complete the IRS Form 990 Report by June 1.
